1. The program for which this MOU is signed is to be known as "Student Benefit Program – Accounting Shiksha & Digital Marketing Masterclass" of ITAA Education Pvt. Ltd.
2. The two parties to this Memorandum of Understanding, with the intention of both being legally bound, accept the following terms and conditions:
  - I. This Student Benefit Program is job oriented and syllabus for the courseware is design by **ITAA Education Pvt. Ltd.** after doing research of industrial Accounting requirement. **ITAA Education Pvt. Ltd.** holds complete authority to make any changes in the syllabus of the course without any prior information. If at all any major changes is supposed to be made in the syllabus of the courseware then that changes will be made in co-ordination with **Daar-UI-Rehmat Trust's A.E. Kalsekar Degree College.**
  - II. Marketing Activities including seminars will be conducted in College premises by **ITAA Education Pvt. Ltd.** & these activities are non-chargeable. **ITAA Education Pvt. Ltd.** will also be using college classrooms & projector of **Daar-UI-Rehmat Trust's A.E. Kalsekar Degree College.**
  - III. **Daar-UI-Rehmat Trust's A.E. Kalsekar Degree College** for marketing activities, seminar & demo lectures as and when these facilities are available and without disturbance of college schedule
  - IV. After successfully completion of Student Benefit Program, the student will be awarded certificate from "**Daar-UI-Rehmat Trust's A.E. Kalsekar Degree College.**"
  - V. The syllabus of the courseware is developed by **ITAA Education Pvt. Ltd.** and cannot be used in any other course without prior permission from **ITAA Education Pvt. Ltd.**

- VI. ITAA Education Pvt. Ltd. holds complete authority for cancelling the admission against the misbehavior of student /candidate.
  - VII. Authority to take admissions& fees lies with **Daar-UI-Rehmat Trust's A.E. Kalsekar Degree College** which can be decided after mutual discussion.
  - VIII. **Daar-UI-Rehmat Trust's A.E. Kalsekar Degree college** will provide Computer lab along with the projector will be utilized by **ITAA Education Pvt. Ltd.** for conducting the Student Benefit Program.
  - IX. The total course fees will be **Rs:4500/- for Accounting Shiksha&Rs. 5000/- for Digital Maketing Masterclass.** ITAA Education Pvt Ltd will receive **Rs: 3300/-&Rs. 3800/-** per student respectively and **Daar-UI-Rehmat Trust's A.E.
