Tata STRIVE intends to engage with third year students of your institute to conduct the Retail Sales Associate course. This course involves 103 hours of classroom duration, 42 hours of on-job training, and 16 hours of field visit (outside of classroom hours), and will be implemented from December 2017 to May 2018.

** YDM - The Youth Development Module is integrated with the domain courses that Tata STRIVE offers, so as to address both cognitive and non-cognitive skills. It focuses on a 360-degree development of youth helping learners realize their potential while making them job ready. It is one of the main differentiators in the Tata Strive training programme. The Tata STRIVE Programme seeks to develop youth holistically, by focusing on the connection between the Head-Heart-Hand. Through these programmes, Tata STRIVE creates the space for beneficiaries to realize their values, beliefs and potential leading to inner transformation. The Youth Development Module consists of the following sub modules

- Mindfulness practices

- 10. Timely incident reporting to institute, if any
- 11. Appraising institute about any changes in the programme
- 12. Coordinate guest visits, industry visits, on-job training and placement drives
- 13. Conduct parent engagement programs for enrolled students with support from Institute
- 14. Tata STRIVE will promote the courses through leaflets, stalls, posters and through Tata STRIVE brandings in classrooms, where applicable
- 15. Tata STRIVE to use the logo of the Institute in marketing material and certificates after agreeing mutually
- 16. Tata STRIVE will provide placement support by inviting interested employers to participate in the placement process after students completing their training. However, Tata STRIVE does not guarantee the placement of the students either within or outside the Tata group

Role of AE Kalsekar Degree College

- Institute to support in facilitating orientation sessions for students in Institute premises and actively
 promote the programme for better participation.
- Spaces with high visibility (reception, public spaces, cafeteria and notice boards) to be allocated within the institute to Tata STRIVE for branding purpose only.
- 3. Institute management to provide full support for promoting this programme through seminars, orientation and parent engagement.
- 4. Institute to encourage parents of students to attend parent engagement sessions in institute premises.
- 5. Institute to provide sufficient number of classroom(s) available to train students in batches of 30-35 with projector(s) and other training aids and electrical connections for programme execution.
- 6. Batch will be formed with a minimum 30 students. Institute to support in retention of enrolled students.
- Institute to share with the students, information related to orientation and enrolment date and time and any other activities before formation of batches.

- 8. Institute to provide support in scheduling the programme along with Tata STRIVE by providing the batch timings, list of holidays and advance intimation on any other college activities.
- Institute to provide Tata STRIVE access to computer labs with internet connectivity whenever required (Schedule will be discussed and shared in advance) and any other infrastructure to enable delivery of assessments and activities during the course.
- 10. Institute to provide Internet connection provision for facilitators and counsellors in IT lab.
- 11. Institute to provide space to Counsellor for the purpose of counselling.
- 12. Institute to provide Single Point of Contact (SPOC) as contact person for any support related to this programme.
- Institute to provide undertaking (in format shared by Tata STRIVE) from enrolled students as acceptance of enrolment for the course.
- 14. Institute to provide support in ensuring maximum attendance, and timely action is taken for regular absentees.
- 15. Institute to provide necessary permissions for on-job training, wherever applicable.
- 16. Institute to provide space for holding placement drives for students who successfully complete the course.
- 17. Institute to ensure that all interested students attend placement drives; for students not interested, institute to ensure that the student submits an undertaking to Tata STRIVE stating the reason.
- 18. Institute to share institute logo and authorized signature for the purpose of certification
- 19. Institute to provide support for any industry partner visits in institute premises
