3) As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:


- 1 Any act of Indirective, Teasing or Handling with Rudeness.
- 2 Any act that Prevents, Disrupts the Regular Academic Activity.
- 3 Any activity which is likely to cause Abuse, Harassment, Psychological Harm or create Fear or Apprehension.
- 4 Any Act of Financial Extortion or Forceful Exploitation.
- 5 Any Act of Physical Abuse causing Assault, Harm or danger to Health.
- 6 Any Act of abuse by spoken words, emails, SMS or public insult etc.
- 7 Any Act of injury or infringement of the fundamental right to the Human dignity.
- 8 Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal force, trespass or intimidation.
- 9 Any unlawful assembly or conspiracy to ragging.

4) Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments:

- 1 Debarring from appearing in any national test / University Examination.
- 2 Suspension from attending classes and academic privilege.

6. Cancellation of admission.
7. Banishment from the institution for period ranging from one to four semesters.
8. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.
